### II. Public Hearing

A. Report on Bond and Override Expenditures, pursuant to A.R.S. § 15-481 (Y) – The board will hold a public hearing to report on bond and override expenditures.

## Discussion:

A Public Hearing is required, as mandated by two applicable statutes. A.R.S. §15-491(K) and §15-481(Y). The three main funding categories are: Extra-Curricular \$372,748, Instructional \$374,061, and Co-Curricular \$92,991.

This year's election is intended to secure \$400,000 in funding to support teacher salaries within these three categories.

The Co-Curricular category includes non-athletic programs such as music, knowledge bowl, and other academic extracurriculars.

The total Bond Expenditures was \$3,871,168 for FY 24-25. This was spread across in: Furniture/Equipment \$9,600. Const. Supplies \$103,124. Professional Services \$374,034. Construction \$3,384,410.

Total bond funds available is \$6,786,575, of which \$3,871,168 has been expended, and \$2,915,407 is the fund balance. There are still Bonds available for sale. Of the \$15,000,000 of bond funds, there are \$8,213,425 available for sale.
